We have a couple new faces around campus! I am excited for the new energy and direction this team has.



### Museum Meanderings!

#### Welcome back!!!

Last month you were informed on how the museum building came to be built. Way back in 1838, lowa Lodge #1 decided that they needed a place to hold their meetings so, they placed this notice for building bids in the July 31, 1838 Mineral Point *Miners Free Press*.

#### NOTICE.

ROPOSALS will be received, until the 20th day of August next, for building a lodge for the I. O. of Odd Fellows, at Mineral Point, of the following dimensions, viz: the building to be 26 by 32 feet, two stories high, a stone foundation laid in lime and mortar, with a good substantial frame erected on the same; to be weather-boarded on the side and ends with oak or pine: the front to be of seasoned pine plank, with columns, balustrade, and finished according to the draft; the roof to be sheated and shingled with good pine shingles; two pine floors, to be tongued and grooved; the stories to be divided in the following manner, viz: one room on each, 18 by 32 feet, a recess in front of 8 by 16 feet, on each side of which are to be a room of 8 feet square, in each of which, on the lower story, shall be a flight of stairs; the height of the lower story to be 94 feet, and of the upper 84. The contractor to furnish all materials, and give security for the faithful performance of his contract. A draft and plan of the building can be seen by calling on M. V. Burris, who will receive the proposals for, and give any information required respecting the above. Mineral Point, July 31, 1838.

It would be interesting if someone knew what the cost was to construct the building in 1838. Information on the builder has not been found, but the land that the building was erected on in 1838 was just outside the boundaries of Mineral Point's surveyed lots. After lowa Lodge #1 let the building go back to the lien holders in 1843, the building became a rental property with a set of steps leading to the second floor that were built on the right side of the building. There are pictures in the museum showing the steps and an addition that was added to the back of the building.



#### **GRAND REPRESENTATIVES REPORT 2023**

Dear Brothers and Sisters,

We wish to thank the Grand Lodge and Grand Encampment of Wisconsin for the privilege to represent Wisconsin at the Annual Communication of the Sovereign Grand Lodge held at the Marriott downtown in Des Moines, Iowa. Brother Loren Cunningham represented the Grand Lodge and was assigned to the International Issues Committee, and Constitutions and By Laws Committee. Brother Jeffery Jones represented the Grand Encampment and was assigned to Patriarchal Degrees Committee.

Sunday, we attended the Sovereign Grand Lodge Representatives orientation at 9:00 AM. Sovereign Grand Lodge Warden candidates Tom Calabrese, Dorian Sherman, and Rick Boyles gave their speeches. Ron Hanson withdrew his name as a candidate for health reasons at this time. In the afternoon we attended the Memorial services. Which were held for all the Past Officers of the Sovereign Grand Lodge, International Association of Rebekah Assemblies, General Military Council who passed away this last year.

Award to Higher Education, Living Legacy Award, Make a difference I.O.O.F. Award. Given to the Grand Master the I.O.O.F. Award to Higher Education. Given to the Grand lodge was the I.O.O.F. Award to Higher Education. Given to The Grand Lodge for the paper from the INTERNATIONAL PRESS ASSOCIATION besides the other top awards was MONTHLY 1<sup>st</sup> PLACE TIE BEST COLUMN, MONTHLY 1<sup>st</sup> PLACE LAYOUT & DESIGN, MONTHLY 1<sup>st</sup> PLACE NEWS CONTENT, MONTHLY 1<sup>st</sup> PLACE JURISDICTIONAL LEADERSHIP, MONTHLY 1<sup>st</sup> PLACE BEST USE OF PHOTOGRAPHY.

Tuesday Evening Change of Command for the General Military Council was held in Grand Form. Installed was General Commanding Howard G. (Doc) Malin.

Wednesday Evening the Installation and dinner was held.

Thursday the calendar was completed. Jewels were exchanged and the formal closing of the Sovereign Grand Lodge for 2023. The invitation to hold Sovereign Grand Lodge at Pittsburgh, PA, next year accepted.

Now for everything that was brought to the floor and moved one way or the other. The following table gives every Bill, Resolution, Committee report that was voted on. The one to be aware of that effects all of us is Bill 26 -2022.

Bill No. 26 – 2022 – Layover to 2023 - Adopted

Rep. Adams of Minnesota from the Committee on Communications presented the following Bill, which was referred to the Committee on Legislation.

TITLE: A Bill to amend Chapter XLVI, by the addition of Section 9, [Page XLVI-3] of the Code of General Laws regarding the Policy on Internet Content.

Be it enacted by The Sovereign Grand Lodge, I.O.O.F.:

That Chapter XLVI, be amended by the addition of the following, to read as follows:

SEC 9 Policy on Internet Content

#### A. Scope

This policy provides guidance for member use of "Internet Content" social media, which should be broadly understood for purposes of this policy to include blogs, wikis, microblogs, message boards, chat rooms, electronic newsletters, online forums, social networking sites, and other sites and services that permit users to share information with others in a contemporaneous manner.

#### **B.** Procedures

The following principles apply to professional use of "Internet Content" on behalf of I.O.O.F. (Independent Order of Odd Fellows) as well as personal use of social media when referencing I.O.O.F. Members need to know and adhere to the I.O.O.F. Ritual; The Sovereign Grand Lodge Code of General Laws of the I.O.O.F., and I.O.O.F. Rules for Internet Content as follows:

C. I.O.O.F. Rules for Internet Content


- (1) To ensure our fraternity represents itself to the highest standards we must self-regulate our social media actions by individual restraint.
- (2) Odd Fellows must conduct social media activities in a way that reflects a positive image of the fraternity.
- (3) All IOOF-related social media accounts must be separate from personal accounts when practical.


- (4) Odd Fellows must be aware that postings are a permanent record; and therefore, should reflect the highest standards of morality and integrity.
- (5) Postings should not bring discredit to Odd Fellowship, nor should they fit within the definition of Un-Fraternal Conduct as defined by The Sovereign Grand Lodge Code of General Laws of the I.O.O.F.
- (6) It is the expectation that private Odd Fellow groups on social media are open to Odd Fellows from jurisdictions recognized by The Sovereign Grand Lodge. It is therefore understood that any administrator(s) of such groups properly verify that any members are Odd Fellows in good standing of recognized jurisdiction(s). Any posts in these groups will be appropriate and follow the guidelines outlined in this social media policy.
- (7) There shall never be discussion related to the business and what is discussed within a Lodge.
- (8) There shall never be discussion related to petitions, applications, background checks, investigation of an applicant, or regarding balloting on an applicant.
- (9) If you should ever leave the I.O.O.F., these rules will continue to be fully applied and binding.
- (10) Before you upload photos/video to Social Media, think about the photo's content and the consequences of your actions. Obtain the person's permission to use private images.
- (11) Anyone who wishes to take photos/videos in Lodge must obtain the permission of the Noble Grand and is to ask the permission of those present if they wish to be photographed.
- (12) Information about Lodge social activities must comply with the regulations already in place for them (for example no reference to alcohol).
- (13) All photo/video material obtained within an event of The Sovereign Grand Lodge shall become copyrighted of The Sovereign Grand Lodge and may only be distributed with permission of the Sovereign Grand Master.
- (14) Only The Sovereign Grand Lodge of the I.O.O.F can make authoritative statements on behalf of the I.O.O.F.
- (15) The Sovereign Grand Lodge is the absolute authority of the I.O.O.F. You should always be mindful that Social Media activities may invoke penalties as described in The Sovereign Grand Lodge Code of General Laws of the I.O.O.F., Chapter XXXVIII relating to trial, suspension, and/or expulsion for any un-fraternal behavior.

- · 2 cups all-purpose flour
- 2 teaspoons ground cinnamon
- · 1/2 teaspoon nutmeg
- · 1 teaspoon baking soda
- 1/2 teaspoon salt
- · 4 cups peeled and finely chopped tart apples, I use Granny Smith

#### Frosting

- 1 (8-ounce) package cream cheese, softened
